




IRPT – IRAN Post-Trade System

Modernized Registry with a Hybrid Structure








KARA II – *Enhanced Broker Electronic Portal*

DARA – Integrated Portal for Capital Market Stakeholders




- Modern UI, mobile compatible,

- Supporting millions of first-time investors




